It has been nine years since we last hosted a convention in District III. Many volunteers have worked diligently to make this happen. So, now you have an opportunity to share in this exciting accomplishment of committal work! We expect National President Joseph Beaudoin to be in attendance and we will have an NARFE Legislative expert, either Dan Adcock or a staff member, present an update on National Legislative Issues.

The Hilton Ontario Airport Hotel is located in the Inland Empire just three minutes from the Ontario International Airport.
