

RECENT NATIONAL CHANGES

NARFE NATIONAL CONVENTION 2016

- BYLAW CHANGES
 - ONE MEMBER ONE VOTE
 - OPTIONAL CHAPTER MEMBERSHIP
- **EFFECTS ON NATIONAL ORGANIZATION**
 - ELIMINATED E-CHAPTER
 - ELIMINATED PROXY AND REPRESENTATIONAL VOTING
 - ELIMINATED NATIONAL CONVENTION IN FAVOR OF NATIONAL CONFERENCE
 - ELIMINATED DEBATE AND DISCUSSSION OF NATIONAL GOVERNANCE BY MEMBERSHIP
 - ELMINATED MEET AND GREET WITH NATIONAL CANDIDATES

EFFECTS ON CA FEDERATION

- REQUIRES ONE MEMBER ONE VOTE AT THE FEDERATION LEVEL CHANGES FEDERATION MEMBERSHIP TO INCORPORATE NATIONAL ONLY MEMBERS
- ELIMINATES THE NEED TO BELONG TO A CHAPTER TO PARTICIPATE IN FEDERATION ACTIVITIES

2019 CA FEDERATION CONVENTION

CHANGED BYLAWS TO:

- INCORPORATE NATIONAL ONLY MEMBERS INTO THE FEDERATION
- CHANGE VOTING TO ONE MEMBER ONE VOTE AND ALLOW NATIONAL ONLY MEMBERS TO VOTE AT CONVENTION
- RETAIN CONVENTION PROCESS FOR CONDUCTING FEDERATION BUSINESS
