Approximately 1% of the California NARFE membership attends the odd year Conventions which is not a true representation of the full membership to be the only members allowed to vote.

# 4b. Bylaw wording/situation if resolution is adopted:

True representation of the approximately 11,000 NARFE members in California in voting for leadership and changes to Bylaws and on resolutions cannot be done only at the Federation Convention. In 2021, only 0.9% of the California state membership was in attendance at the Convention.

All of the California NARFE membership must have a voice in the direction of the Federation.

A single copy of the resolution form must be received by the Federation Secretary no later than 60 days prior to the opening date of the Federation Convention, as specified in the convention call letter. All bylaw resolutions and general resolutions will be numbered and assigned to the Federation Bylaw/Resolution Committee for review and certification for presentation to the CSF Convention. The Committee will determine if the resolution meets the submission requirements set by the CSF Executive Board. A proposed resolution that does not meet these requirements will be returned to the submitter with an explanation of the reason (s) for non-acceptance. The committee may amend the proposed resolution, combine it with similar resolutions, or prepare a substitute without changing the intent of the original proposed resolution. The committee then recommends an action to the convention members or to the CSF Executive Board if considered for a referendum.
