A/V Equipment: We discussed the needs and the need to make sure they all work. Gregg Pericich said he could bring the portable microphone that he has for his district that could be used for the Reception and the Banquet, to save that cost.

Membership: RVP Robert Ruskamp sent current membership numbers to President Ingram. They show that we are still losing members.

Resolutions: DVP VIII Stephen Smith created a procedure for presenting the one resolution that was submitted by an unaffiliated member, but still had some questions. He went through the process. If no one stands to sponsor the amendment, or no second is given, the resolution dies. If there is a supporter, they would have ten minutes to give their supporting argument. There could

be debate, but for a total of thirty minutes. Debate is over after thirty minutes. If someone has an amendment to the original proposed bylaw amendment, they present it and then there needs to be a second to that amendment and then discussion. He will ask if anyone has been designated to support this original amendment.

Leadership Workshop: Treasurer Hall and President Ingram met and will produce a handout for this workshop. President Ingram will print out a survey to be handed out and turned in by attendees at the end of the convention.
