Senate Advances Minibus Budget with Multiple Amendments

In a significant development on the Senate floor, a long-awaited agreement has been reached to advance a three-bill government-funding package (H.R. 4366), encompassing Agriculture-FDA, Military Construction-VA, and Transportation-HUD spending bills, totaling \$279.3 billion, equivalent to about 17% of overall discretionary spending. This marks a critical bipartisan milestone in the fiscal 2024 funding process.

Before reaching the final passage vote, Senators will first deliberate on 40 proposed amendments covering a wide array of issues, including spending cuts, an anti-shutdown bill, Covid mask mandates, and more. Among the measures, some are subject to a simple majority threshold, while others require 60 votes for adoption. The 27 amendments that were adopted as of Wednesday, October 25, cover measures related to veterans' electronic health records, toxic exposure studies among veterans, mammography services funding, and the Federal Aviation Administration's aeronautical information management program.

One significant amendment that may be added to the bill, Senate Amendment 1092, focuses on requiring reporting regarding telework by employees of agencies funded under the Consolidated Appropriations Act, 2024. The amendment aims to improve oversight and quality control of remote work arrangements and assess the cost savings that could be achieved by adjusting locality rates for employees who perform the majority of their working hours in a locality pay area with a lower locality rate than their official worksite (but continue to receive the higher locality rate).

House Elects Speaker Mike Johnson, Gets Back to Work on Government Funding

After more than three weeks of tumult, the United States House of Representatives has elected a new Speaker, Rep. Mike Johnson, R-LA, and returned to its efforts to pass appropriations bills to fund the government.

NARFE Supports Windfall Elimination Provision Reform Bill Introduced by Rep. Arrington NARFE National President William Shackelford issued a statement In response to Rep. Jodey Arrington, R-TX, introducing the Equal Treatment of Public Servants Act, legislation that would provide much-needed relief to civil servants financially punished by the Windfall Elimination Provision (WEP)
